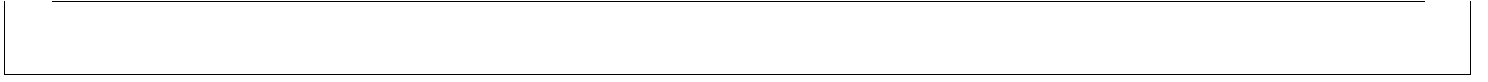

**NOTICE UNDER THE PERSONAL DATA PROTECTION ACT 2010**  
**NOTIS DI BAWAH AKTA PERLINDUNGAN DATA PERIBADI 2010**

The Personal Data Protection Act 2010 (the "Act"), which regulates the processing of personal data in commercial transactions, applies to **Yayasan Sime Darby** ("ou", "us" or "we"). For the purpose of this written notice ("Notice"), the terms "personal data" and "processing" shall have the same meaning as prescribed in the Act.

6. Subject to provisions of the Act:
